

RULES AND REGULATIONS

I. AIM AND PURPOSE

- a. The Surana & Surana Environment Law Moot has been envisaged with the aim of creating opportunities for learning the development of jurisprudence on emerging trends in Environment Law besides developing cutting edge skills in research, writing and advocacy.
- b. Further, it is aimed at facilitating the evolution of Environment Law through jurisprudential analysis of the existing law and consequential emergence of new laws.

II. DEFINITIONS

- Advanced Rounds: It shall refer to the Octa Finals, Quarter Finals,
 Semi Finals, and a Final Round of the Competition.
- Competition: It shall refer to the VI edition of the Surana & Surana and UILS School of Law, National Environmental Law Moot Court Competition, 2023.
- 3. <u>Disqualification</u>: It shall render a team invalid to continue participating in the Competition.
- 4. <u>Judge</u>: It shall refer to any person appointed to evaluate a Participant's Memorial or Oral Pleading.
- Memorial: It shall refer to the written arguments submitted by each team, on behalf of both the Parties, according to the official competition rules.
- <u>National Administrator</u>: It shall refer to the Dean, School of Law, UILS (Chairman, Moot Court Association, UILS).
- 7. **Oral Rounds:** It shall refer to a team's pleadings, composed of both speakers, submitted orally in front of the judges, on behalf of one of the parties, against another team representing the opposing party.

- 8. <u>Parties</u>: It shall refer to the parties to the dispute as identified by the moot proposition as Informant/ Appellant and Opposite Party/Respondent.
- Penalties: It shall refer to points deducted for violation of any Rules mentioned hereunder. Note: The organizing committee reserves the authority to disqualify any team if there is any grave violation of these Rules.
- 10. **Preliminary Rounds**: It shall refer to the Oral Rounds which will take place prior to the Advanced Rounds of the Competition for the purpose of determining the teams which will proceed to the Advanced Rounds.
- 11. <u>Rules</u>: It shall refer to these official Competition Rules and such other applicable supplements to these Rules published by the Organizing Committee.
- 12. <u>Organizing Committee</u>: Shall mean and include those members mentioned in Clause XX.
- 13. <u>Scouting</u>: It shall refer to the act of attending a round in which the members of the team or any person related to the team are not competing.
- 14. <u>Team code</u>: It shall refer to the unique number allotted to each participating team for the purpose of this Competition. This would primarily be used for all submissions of memorials.
- 15. <u>Competition Team code</u>: For the oral rounds based on the fixtures competition team codes will be allotted through a draw of lots as part of the orientation.

III. VENUE AND DATE

The 6^{th} Surana & Surana & UILS Environment Law Moot Court Competition, 2023 shall be held virtually from $1^{st} - 3^{rd}$ September 2023.

IV. LANGUAGE

The competition shall be in English language only.

V. ELIGIBILITY

The competition is open for students pursuing bachelors in law in either three year or five-year course during the current academic session.

VI. TEAM COMPOSITION

- a. Each team should consist of a minimum of 2 and maximum of 3 members. This number cannot be modified under any circumstances.
- b. There shall be 2 speakers and 1 researcher designated for each team. The researcher shall be allowed to argue with prior permission of National Administrator in case of illness of the designated speakers or any other justifiable circumstances.
- c. Each team will be provided a team code during orientation. Teams should not disclose the identity of their institution; such disclosure shall invite penalties including disqualification. The decision for the same shall be at the discretion of the National Administrator.
- d. The National Administrator for the purposes of this competition will be The Director, UILS, Panjab University, Chandigarh.

VII. REGISTRATION

- a. Online registrations are open from 8th August 2023. The teams must register online by 22nd August 2023. Teams will have to register online at www.moot.in and mail the same at www.moot.in and was a same at <a h
- b. No temporary registration requests will be entertained. Kindly refrain from sending such requests to Surana & Surana or UILS.
- c. Participants will receive an automated system generated acknowledgement on successful submission of registration. Participants will receive an approval as acceptance of their request for participation latest by **23**rd **August 2023** or earlier.

d. Registration Process

- **Option 1** The Registration form cum Approval letter as provided in the rules duly signed & sealed by your university / college / moot society.
- Option 2 Upload both (i) & (ii) together as a single PDF
- (i) The Registration form cum Approval letter (without seal & signature) as provided in the rules duly filled along with
- (ii)Scanned copy of authorisation letter with sign and seal from your university /

college / moot society.

Or

An email communication from the official id (to be filled as notification email id during online registration process) of the institution, from your university / college / moot society to complete the registration process.

Note:

- Signatories on the registration form should be any of the following: Faculty-in-charge of MCA / MCS / MCC, Registrar, Dean, Principal, Director, Chancellor, or Vice-Chancellor
- 2. Registration without the scanned copy of the approval letter / an email communication from the college/institution/university or duly attested registration form will not be valid.

General Guidelines:

- No change in the names & composition of the team shall be permitted after the receipt of the Registration Form, except at the sole discretion of the Administrators.
- Only one Team is allowed per institution. Participants will receive an automated system- generated acknowledgment on the successful submission of registration.
- 3. A provisional team code shall be allotted to the registered teams by the Host University after providing a receipt of final registration and payment via mail uils.suranamoot2023@gmail.com . Any delay in the completion of the final registration process within the stipulated deadline may result in the cancellation of the participant's confirmed provisional registration at the administrator's sole discretion.
- 4. The participants are strongly advised to ensure that there are no spelling errors in the information provided in

pursuance of the participation certificates.

- 5. In the event a team drops out of the competition or is disqualified, the team next in line as per registration data (when the registration exceeds the permitted 32 teams) will be offered the chance to participate in the competition at short notice. Such teams will have to submit their memorials to be eligible at least 3 days prior to the dates of the competition.
- e. Soft copy of the registration and approval letter/ an email communication as a **single PDF** to be sent by email to <u>uils.suranamoot2023@gmail com</u> marked as 6th SURANA & SURANA AND UNIVERSITY INSTITUTE OF LEGAL STUDIES NATIONAL ENVIRONMENTAL LAW MOOT COURT COMPETITION REGISTRATION as subject of the mail latest by **20th August 2023**.

The provisional team code shall be allotted to the registered teams by Host University soon after receiving of registration particulars.

On receiving the provisional team code from moot committee/society of UILS you may proceed to pay the registration fees.

Fees once paid will not be refunded.

VIII. ORIENTATION

a. There will be an Orientation Program for all the participants on 1st September 2023 (Friday) followed by draw of lots & exchange of memorials. Competition Team codes and side will be allotted during orientation only.

- b. It will be mandatory for the teams to keep their cameras on during the Program. While their cameras are on, each member must ensure that proper dress code is followed, and decorum is maintained.
- c. Preceding the Orientation there will be a brief Online Registration process.

 The participants will be asked to verify their identity and cross-check the personal details that have been filled out. For this exercise, the participants are advised to keep their personal ID card at hand.
- d. Team codes allotted previously by the host university are only to be used. for the purposes of submission of memorial. The teams will be allotted fresh competition codes through a draw of lots at the end of the orientation session, after which team codes previously allotted will cease to be valid.

IX. ROUNDS

There will be two preliminary rounds, an octa finals, a quarter-final round, a semi-final round and a final round. Octa final rounds will be held if participants exceed 30 and above.

IX. A. Preliminary Round

- a. There will be two preliminary rounds of arguments per team, once for applicant & another for respondent.
- b. No team will face each other more than once in the preliminary rounds.
- c. Each team will face a different bench in their second round of arguments. The Preliminary rounds will be held on 1st and 2nd September 2023 (Saturday).
- d. Top Eight teams from the Preliminary Rounds will advance to the Quarter finals rounds that will be decided on:
 - i. Win points
 - ii. Win points + Aggregate raw points
 - iii. Win points + aggregate raw points (in case of tie minus memorial marks)

Memorial marks will be added to the scores of both the preliminary rounds only.

VIII.B. Octa Finals / Quarterfinals / Semi-finals Round / Final Round:

- a. Lots / power matching will decide the side of arguments in Quarterfinals, Semi-finals & Finals.
- b. The Octa Finals / Quarter Final and Semi Final Rounds will be held on **2 September 2023.**
- c. The Finals will be held on 3rd September 2023.
- d. The Octa Finals / Quarter Finals / Semi-finals will be a knockout round.

X. RESULTS

Results of the preliminary rounds shall be announced after the completion of rounds of all the teams. Similarly, the results of the Quarterfinals / Semifinals shall be announced after completion of the rounds of all qualified teams of respective rounds. The results of the final rounds shall be announced in the Valedictory Ceremony.

XI. MEMORIALS

The following requirements for memorials must be strictly followed. Non-conformities will be penalized:

- a. Each team must prepare memorials for both parties to the dispute (Applicant and Respondent).
- b. The Soft copy of the memorials from both sides in word format (*.doc or *.docx) must be mailed to: mootcourt@lawindia.com and uils.suranamoot2023@gmail.com by 25th August 2023 latest by 23:59 p.m.
- c. Soft copy of the memorials should be emailed with the subject as "Team Code- Memorial Submission". The memorials shall be submitted in Word format. The file shall be named as "Team Code- Memorial for Applicant" and "Team Code- Memorial for Respondent" respectively. The memorials for the two sides shall be attached as two separate attachments in the same email communication.
- d. Memorials beyond a delay of 48 hours will not be accepted. Late submissions will be penalized by two points each per memorial for every 6 hours of delay after the due date. This will by default

disqualify the team from participating in the Competition.

The penalties will be applicable as follows:

- e. Once the memorials have been submitted, any revisions, supplements, or additions will be allowed at the discretion of the National Administrator.
- f. The memorials must be submitted on typed A4 size paper printed on both sides and must contain:
 - i. Table of Contents
 - ii. Index of Authorities
 - iii. Statement of Jurisdiction (not more than 1 page)
 - iv. Statement of Facts (1 page only and argumentative statement of facts would attract penalties)
 - v. Statement of Issues (not more than 1 page)
 - vi. Summary of Arguments (not more than 2 pages)

- vii. Arguments Advanced (not more than 15 pages)
- viii. Prayer (not more than 1 page)
- g. Uniform font style is to be followed throughout the Memorial. The Font Style should either be Times New Roman or Garamond. The font size of the text should be 12 points (double space) and the font size for footnotes should be 10 points (single space), Double spaces to be adhered to between two footnotes..
- h. The memorial must have a margin measuring one inch on all sides of each page.
- i. All the pages of the memorial, except the Cover Page shall be numbered. The page numbering should be on the top right corner of each page.
- j. The blue book: A uniform System of Citation (20th Edition) should be followed in the written submission throughout Non-Compliance will result in a penalty of 1 mark per page. Substantive/speaking footnotes are strictly prohibited.
- k. Covers must be placed on briefs as follows:

Applicant: Blue Colour; Respondent: Light Red Colour.

- I. The cover page of the memorial must state the following:
 - a. The case title.
 - b. Identify briefs as Applicant & / Respondents as is applicable.
 - c. Provisional Team Codes (see, Rule VII (e) on the top right corner of Cover Page.
- m. The teams are advised not to reveal their personal identities or the identity of their institution anywhere in the memorials. Violation of this provision shall result in penalties including deduction of marks or disqualification from the Competition. The decision of the National Administrator will be final & binding.
- n. The teams may share a separate paper book (compendium) of not more than 50 pages, which will carry all the annexure and case laws that have been referred to in the memorial. The paper book will have a white cover. The teams may submit through screen sharing with judges or submitted during virtual registration before commencement of the Competition as advised by the organisers. Any identifying marks/seal of the college/university shall attract severe penalties including disqualification.

XII. ORAL ROUNDS

XI.A. Preliminary Rounds, Octa Finals & Quarter finals

- a. Each team will get a total of 30 minutes to present their case. This period of 30 minutes is inclusive of the time reserved for rebuttal and sur-rebuttal.
- b. The division of time is at the discretion of the team members, subject to a maximum of 15 minutes per speaker. It is the duty of the team to inform the division of time to the court clerk before the arguments begin.
- c. Oral Pleadings shall be confined to the pleading in the Memorials.
- d. Passing of notes discreetly to the speakers by the researcher during the rounds is allowed.
- e. The attendance of the Researcher at the time of Oral Pleading Rounds is compulsory.

XI.B. Semi-finals & Finals

- a. Each team will get 45 minutes to present their case inclusive of the time reserved for rebuttal.
- b. The division of time is at the discretion of the team members, with a maximum of 25 minutes and minimum of 20 minutes per speaker.
- c. Oral Pleadings shall be confined to the pleading in the Memorials.
- d. The attendance of the Researcher at the time of Oral Pleading Rounds is compulsory.

XIII. DRESS CODE

The dress code shall be advocate's attire (black and white formals including coats) during the competition rounds.

XIV. SCOUTING

Teams will not be allowed to observe the orals pleading rounds of any other teams. Scouting is strictly prohibited. Scouting by any of the team members shall result in disqualification from the Competition.

XV. SCORING

A. Orals Rounds

- a. The parameters for judging the oral presentation on a scale of 0 100 points are:
 - i. Knowledge of facts
 - ii. Logic and reasoning
 - iii. Organization and clarity
 - iv. Persuasiveness
 - v. Deference to the court
 - vi. Proper and articulate analysis of the issues arising out of facts.
 - vii. Understanding of the legal principles directly applicable to the issues
 - viii. Ability to clearly explain the legal principles in general keeping to the time allotted.
 - ix. Knowledge and use of legal sources & authorities and general principles of Environment Law.
 - x. Ingenuity (ability to argue by analogy from related aspects of law)

B. Written Submissions (Memorials)

- a. The memorials shall be marked on a scale of 1-100 points each.
- b. Any revisions, supplements, or additions to the memorials after submission shall attract severe penalties subject to the discretion of the National Administrator.
- c. Award of the points shall be based on the following parameters:
 - i. Neatness, legibility, no typographical errors, or format errors
 - ii. Logical progression of ideas
 - iii. Effective use of headings to outline arguments.
 - iv. Understanding essential legal issues presented
 - v. Focus on essential (not collateral) issues.
 - vi. Clear, concise and unambiguous writing style
 - vii. Forceful and persuasive presentation

- viii. Integration of facts into legal argument
- ix. Understanding of strengths and weaknesses of case
- x. Discussion of viable alternative arguments
- xi. Understanding and analysis of authority
- xii. Proper use of citations and citation form
- xiii. Effective use of authority to support arguments
- xiv. Ability to distinguish adverse cases.
- d. Non- compliance of the rules mentioned in Clause X above shall attract severe penalties.

XVI. AWARDS

- a. Winner Rs. 10,000/-
- b. Runner's up Rs.7,000/-
- c. Best Memorial Rs. 4,000/-
- d. Second Best Memorial Rs. 3,000/-
- e. Best Student Advocate Rs. 4,000/-
- f. Second Best Student Advocate Rs. 2,000/-

All participants will be issued participation certificates.

XVII. ANONYMITY

- a. Student counsel may introduce her/himself to the court in the usual manner and may also state
 - her/his names. However, the team's college / institution affiliation may not be mentioned at any time before the awards ceremony.
- b. Further, all team members, coaches, advisors, and observers shall refrain from identifying a team's school at any time and in any manner, including, but not limited to, wearing any identifying items, such as school clothing, ties, patches, or pins or carrying identifying material (such as a book with a college logo, or college seal).

VI. POLICY FOR VIRTUAL ROUNDS

- a) The Oral Rounds for the competition will take place virtually via **Google Meet** platform.
- b) It would be the responsibility of every team to ensure a stable internet connection.

 The audio and video of every member of the team should be clear. Every team must ensure a proper background. The organisers will under no circumstances be obligated to provide the participants with any such facility.
- c) All participants should mandatorily join with their laptops or desktops and other forms of device are to be avoided.
- d) The link or the ID and password for the room on Google Meet will be conveyed to the participating teams before the oral rounds.
- e) Each participating member of every team is advised to install the Google Meet platform on their devices well in time.
- f) Each team is required to join the room at least twenty minutes before the scheduled time of
- g) commencement of the oral rounds.
- h) The participants' camera and microphone shall be firmly positioned throughout the oral rounds to show speakers and to ensure their voices are clearly audible.
- i) All participants must always keep their cameras on during the rounds. Camera to be switched off in case of technical glitches with the permission of the bench.
- j) At the time when one participant is speaking, others are expected to keep their microphones on mute. In case a participant is found disturbing the other pleader anyway, he/she or the entire team to which such participant belongs may be disqualified upon the discretion of the bench.
- k) Each participant is responsible for finding a suitable venue and background to participate. The venue must be a quiet location and one which has adequate and reliable internet connectivity and has a desk and chairs for the oralist. Locations in open spaces or hallways or cybercafés or similar areas are NOT permitted.
- I) Participants are cautioned to ensure that all equipment has a power supply sufficient to last for at least two hours without interruption.

- m) In case of a loss in internet connection, each team will be given a reasonable time to reconnect. If the problem persists the decision made by the organisers shall be final and binding.
- n) In the event where one or both of the speakers could not join due to connectivity issues, the team may be disqualified from the competition and at no circumstances can other members of the team be allowed to switch roles.
- o) Where a team does not appear within 10 minutes of the scheduled time for the round, the round shall proceed as ex-parte.
- p) Compendium & memorials shall be mailed to uils.suranamoot2023@gmail.com along with the team competition codes on completion of the Orientation as directed by the organizers.
- q) Any compiled Research Material (Compendium) or other supplementary documents may be, as per the discretion of the bench, presented by the team by using the "screen sharing" option given they have fulfilled the preceding sub-clause.
- r) Participants will not be allowed to use the feature of personal chat on Google Meet to communicate with their team members or members of the opposing team.
- s) Teams shall not use the internet or any other devices during the rounds for anything, except participating in the rounds.
- t) Participants can only sip water on screen during the competition. Consumption of other beverages or eatables is not permitted. Non-Speakers are to switch off video before drinking water.
- u) Participating speakers and researchers are permitted to join for the Virtual Competition from the same premises/room. However, the screen space shall be independent and the speakers, researcher to represent before the bench through individual/separate devices.
- v) Appropriate court room demeanour is to be maintained. This is mandatory.
- w) Participants are expected to cooperate with the organisers and the judges, in case anyone faces any issue.

x) The organizers shall take best available measures to resolve or mitigate any connectivity issues that may arise. However, in cases where that is not possible, the organizer cannot be held responsible for the unforeseen issues which includes (but are not limited to) – Software failure and connectivity issues.

XVIII. FINALITY OF THE DECISION

The decision of the judge shall be final and binding. The organizers reserve the right to amend the rules of the Competition.
