## RULES OF THE COMPETITION







#### **RULES AND REGULATIONS**

#### I. AIM & PURPOSE

The Surana & Surana and UPES School of Law's National Insolvency Law Moot Court Competition aims to facilitate understanding of evolving jurisprudence in Insolvency Law's emerging trends. It also focuses on enhancing research, writing, and advocacy skills. By participating in this competition, individuals have the opportunity to enhance their legal acumen and contribute to the growth of this specialized field.

#### II. DEFINITIONS

- 1. <u>Advanced Rounds</u>: It shall refer to the Quarter Finals, Semi Finals, and a Final Round of the Competition.
- 2. <u>Competition</u>: It shall refer to the VIth edition of the Surana & Surana and UPES School of Law, National Insolvency Law Moot Court Competition, 2023.
- 3. <u>Disqualification</u>: It shall render a team invalid to continue participating in the Competition.
- 4. <u>Judge</u>: It shall refer to any person appointed to evaluate a Participant's Memorial or Oral Pleading.
- 5. <u>Memorial</u>: It shall refer to the written arguments submitted by each team, on behalf of both the Parties, according to the official competition rules.
- 6. National Administrator: It shall refer to the Dean, School of Law, UPES (Chairman, Moot Court Association, UPES).
- 7. Oral Rounds: It shall refer to a team's pleadings, comprising of both speakers, submitted orally in front of the judges, on behalf of one of the parties, against another team representing the opposing party.
- 8. Parties: It shall refer to the parties to the dispute as identified by the moot proposition as Informant/ Appellant and Opposite Party/Respondent.
- Penalties: It shall refer to points deducted for violation of any Rules mentioned hereunder.
   Note: The organizing committee reserves the authority to disqualify any team if there is any grave violation of these Rules.







- 10. <u>Preliminary Rounds</u>: It shall refer to the Oral Rounds which will take place prior to the Advanced Rounds of the Competition for the purpose of determining the teams which will proceed to the Advanced Rounds.
- 11. <u>Rules</u>: It shall refer to these official Competition Rules and such other applicable supplements to these Rules published by the Organizing Committee.
- 12. Organizing Committee: Shall mean and include those members mentioned in Clause XX
- 13. <u>Scouting</u>: It shall refer to the act of attending a round in which the members of the team or any person related to the team are not competing.
- 14. <u>Team code</u>: It shall refer to the unique number allotted to each participating team for the purpose of this Competition. This would primarily be used for all submissions of memorials.
- 15. <u>Competition Team code</u>: For the oral rounds based on the fixtures competition team codes will be allotted through a draw of lots as part of the orientation

#### III. VENUE AND DATE

Surana & Surana and UPES School of Law National Insolvency Law Moot Court Competition shall be held virtually from 18th – 20th August, 2023. Mr. Abhishek Sinha, Associate Dean, UPES School of Law shall be the National Administrator.

#### IV. LANGUAGE

The competition shall be conducted in the English language.

#### V. ELIGIBILITY

The competition is open for students who are pursuing LLB (three-year / five-year) courses during the current academic year.

#### VI. TEAM COMPOSITION

1. The maximum number of participants per team shall be restricted to 3 wherein only 2 shall be speakers and 1 shall be the designated researcher. The researcher shall be allowed to argue with the prior permission of the court and National Administrator in case of illness of the designated speakers.

**Note:** Only the designated speaker in the Preliminary Rounds shall be eligible for the Best Speaker award.







- 2. No Team Coach, mentors, observer or any other person shall be accompanying registered participating team members.
- 3. Teams should not disclose the identity of their institution; such disclosure shall invite penalties including disqualification. The decision for the same shall be at the discretion of the National Administrator.

#### VII. REGISTRATION

#### **Provisional Registration:**

- 1. Provisional Registration commences from 8th July 2023.
- 2. The **Provisional Registration** shall be done by **July 20th, 2023.** It is mandatory for every university to register provisionally via its moot court's ID at <u>Form</u>.
- 3. Teams will receive confirmation mail of the successful provisional registration from the Host University.

#### **Final Registration:**

- 1. Online Registration for teams commences from 8th July 2023.
- 2. The teams must register online by **August 8th**, **2023.** Teams will have to register online at <a href="https://www.moot.in">www.moot.in</a>.
- 3. After registering online, the teams must complete the **Registration Process** as stated below by sending a copy of the documents for authentication, at <a href="mootcourt@ddn.upes.ac.in">mootcourt@ddn.upes.ac.in</a>.
- 4. Participants will receive approval as acceptance of their request for participation within 2 days from the last date of registration.

#### **Registration Process:**

The following documents are required by the teams at the time of Final Registration:

- An external participation form / approval letter (with seal and signature) as provided in the rules duly filled from the participant's institution / moot society.
- Scanned copy of the receipt of online payment.

#### Note:

Signatories on the registration form should be any of the following: Faculty- in charge of MCA / MCS / MCC, Registrar, Dean, Principal, Director, Vice-Chancellor.







#### **General Guidelines:**

- No change in the names & composition of the team shall be permitted after the receipt of the Registration Form, except at the sole discretion of the Administrators.
- Only one Team is allowed per institution. Participants will receive an automated systemgenerated acknowledgment on the successful submission of registration.
- A provisional team code shall be allotted to the registered teams by the Host University after providing a receipt of final registration and payment via mail (<a href="mailto:mootcourt@ddn.upes.ac.in">mootcourt@ddn.upes.ac.in</a>). Any delay in the completion of the final registration process within the stipulated deadline may result in the cancellation of the participant's confirmed provisional registration at the administrator's sole discretion.
- The participants are strongly advised to ensure that there are no spelling errors in the information provided in pursuance of the participation certificates.
- In the event a team drops out of the competition or is disqualified, the team next in line as per registration data (when the registration exceeds the permitted 40 teams) will be offered the chance to participate in the competition at a short notice. Such teams will have to submit their memorials to be eligible at least 3 days prior to the dates of the competition.

#### VIII. ORIENTATION

- a. There will be an Orientation Program on August 18th, 2023 for all the participants followed by a draw of lots and exchange of memorials. The fixture for the Preliminary Rounds will be disclosed during the orientation only. The orientation will also include an online training session by SCC.
- b. It will be mandatory for the teams to keep their cameras on during the Program. While their cameras are on, each member must ensure that proper dress code is followed and decorum is maintained.
- c. Preceding the Orientation there will be a brief Online Registration process. The participants will be asked to verify their identity and cross-check the personal details that have been filled out. For this exercise, the participants are advised to keep their personal ID card at hand.
- d. Team codes allotted previously by the host university are only to be used for the purposes of submission of memorial. The teams will be allotted fresh competition codes through a draw of lots at the end of the orientation session, after which team codes previously allotted will cease to be valid.

#### IX. MEMORIALS

The following requirements for memorials must be strictly followed.

- 1. Each team must prepare memorials for both parties to the dispute (Appellant and Respondent).
- 2. The soft copy of the Memorials for the Appellant and the Respondent should be submitted through mail to <a href="mailto:mootcourt@ddn.upes.ac.in">mootcourt@ddn.upes.ac.in</a>, with a copy to <a href="mootcourt@lawindia.com">mootcourt@lawindia.com</a> on or before August 11th, 2023 (Friday), 23:59 P.M. IST and the subject of the mail should be marked as "Memorial Submission by Team Code \_\_\_\_\_for Surana & Surana and UPES School of Law, National Insolvency Law Moot Court Competition, 2023".
- 3. Soft copy of the memorials should be submitted via google form link with the subject as "Team Code- Memorial Submission". The memorials shall be submitted in **Word format as well as PDF Format.** The file shall be named as "**Team Code- Memorial for Appellant**" and "**Team Code- Memorial for Respondent**" **respectively.** The memorials for the two sides shall be attached as two separate attachments in the same email communication.







4. Late submissions will be penalized by two points each per memorial for every 6 hours of delay after the due date. **Memorials beyond a delay of two days will not be accepted with due penalty.** This will by default disqualify the team from participating in the Competition.

The penalties will be applicable as follows:

5. Once the soft copy of the memorials has been submitted, no revisions, supplements, or additions will be allowed.







- 6. The memorials must contain the following:
  - 6.1. Cover Page
  - 6.2. Table of contents
  - 6.3. Table of abbreviations
  - 6.4. Index of Authorities
  - 6.5. Statement of jurisdiction Pages
  - 6.6. Statement of facts (1 page only and an argumentative statement of facts would attract penalties)
  - 6.7. Statement of issues
  - 6.8. Summary of arguments (not more than 2 pages)
  - 6.9. Arguments advanced (not more than 25 pages)
  - 6.10. The Prayer Advanced

- 7. The Memorial shall be formatted according to the following specifications:
  - 7.1. Typed on standard A4 size page
  - 7.2. Font Type: Times New Roman
  - 7.3. Font Size for body text: 12
  - 7.4. Font size for footnotes: 10
  - 7.5. The text of the Memorial and Text of Footnotes should be 1.5 lines spaced
  - 7.6. Font size for the cover page may be 14
  - 7.7. Margin: 1 inch or 2.54 cm margin on each side of the A4 size page
  - 7.8. Quotations of sources of 50 words or more in any part of the memorial should be block quoted, indented.
  - 7.9. The participating teams should include a Header and Footer in their memorials to the effect that the Header should mention the full Name of the Competition and the Footer should mention the page number on the bottom left corner and the side on whose behalf the memorial is submitted. Furthermore, the Header must also contain the logos of UPES and SURANA & SURANA on the left and the right side respectively.
  - 7.10. The footnotes must follow the *Harvard Bluebook Method of Citation*, 20th Edition.
- 8. The cover page of the memorial must contain the following information:
  - 8.1. Team Code (on the top right corner)
  - 8.2. The Name of the Competition







- 8.3. The Year of the Competition
- 8.4. Name of the Case (Name of the Parties)
- 8.5. Party for which the Memorial has been prepared
- 8.6. Name of the Forum resolving the dispute
- 8.7 Use Blue color for Appellant and Red color for Respondent

**Note**: The name of the Participating University shall not be revealed on the cover page or any other pages of the memorial. Violation of this provision shall result in penalties including disqualification.

- 9. The teams may share a separate compendium, which will carry all the annexures and case laws that have been referred to in the memorial. The compendium will have a white cover. The teams will retain them and may present them, through the Researcher, to the Judges during the rounds through screen sharing. Any identifying marks/seal of the college/university shall attract severe penalties including disqualification. The soft copy of the compendium will not be accepted after **4:00 p.m. 18th August 2023**.
- 10. All materials submitted will be run through a Plagiarism Checker that detects AI-generated content. The use of Artificial Intelligence such as ChatGPT is strictly prohibited. Any memorial detected to have used AI-generated content will be flagged and the team will face immediate disqualification

#### X. ROUNDS

There will be two Preliminary Rounds, a Quarter – Final, a Semi – Final, and a Final Round which will be conducted virtually. The organising committee reserves the right to conduct an Octa-final round, prior to the Quarter-final round, if in the opinion of the organizing committee such a need arises

#### 1. Preliminary Round / Quarter – Final Round

- 1.1. There will be two preliminary rounds of arguments per team, once on behalf of the Appellant and another on behalf of the respondent.
- 1.2. No team shall appear before each other more than once in the Preliminary Rounds.
- 1.3. Each team will face a different bench of judges in their second round of arguments.
- 1.4. Preliminary, & Quarter-finals will be held on **August 19th**, **2023**, the top 8 (Eight) teams will qualify for the Quarter Finals.
- 1.5. Quarter Final & Semi Finals will be knockout rounds.
- 1.6. Each team will get a total of 40 minutes to present their case. This includes time for rebuttals.







- 1.7. The division of time is at the discretion of the team members, subject to a minimum of **15 minutes** per speaker. Division of time shall be informed to the court officer/moderator before arguments begin.
- 1.8. The researcher shall sit with the speakers at the time of the Oral Rounds.
- 1.9. Extension of time will be allowed only on the judges discretion.

#### 2. Semi-Final Round

- 2.1. The Semi-Final Rounds will be held on **August 20th**, **2023**. The pairing of Teams for the Semi-Final Rounds shall be done by a draw of lots/power matchups.
- 2.2. Each team will get a total of 55 minutes to present their case. Further 5 minutes for rebuttal and sur-rebuttal. (Total time for each team = 55 + 5)
- 2.3. The division of time is at the discretion of the team members, subject to a minimum of **20 minutes** per speaker. Division of time shall be informed to the court officer/ moderator before arguments begin.

#### 3. Final Round

- 3.1. The Final Rounds will be held on **August 20th**, **2023**. The pairing of Teams for the Final Rounds shall be done by a draw of lots/power matchups.
- 3.2. Each team will get a total of 60 minutes to present their case. Further 5 minutes for rebuttal and sur-rebuttal. (Total time for each team = 60 + 5)
- 3.3. The division of time is at the discretion of the team members, subject to a minimum of **25 minutes** per speaker. Division of time shall be informed to the court officer/ moderator before arguments begin.

#### 4. Results (Announcement)

4.1. The Final result and the winners of the various categories will be announced only during the valediction/ prize distribution ceremony on **August 20th**, **2023**.

#### XI. DRESS CODE

The dress code for the competition shall be as per the Bar Council of India Rules for Advocates.

#### XII. SCOUTING

- a. Teams will not be allowed to observe the oral rounds of any other teams. Scouting is strictly prohibited. Scouting by any of the team members shall result in disqualification.
- b. In the virtual format, the presence of any team member in the virtual courtroom of any other team except their own will qualify as Scouting.







- c. In the event that the Organizers have accidentally placed a team in the wrong courtroom, it is the responsibility of the members of that team to immediately notify the Organizers of the same.
- d. The lack of a timely notification to the Organizers will qualify as Scouting.

#### XIII. SCORING

#### 1. Oral Rounds

The parameters for judging the oral presentation on a scale of 0 - 100 points are the following:

- 1.1. Knowledge of facts
- 1.2. Logic and reasoning
- 1.3. Organization and clarity
- 1.4. Persuasiveness
- 1.5. Style, Poise, Courtesy, Demeanour, and Deference to the court
- 1.6. Proper and articulate analysis of the issues arising out of facts
- 1.7. Understanding of the legal principles directly applicable to the issues
- 1.8. Ability to explain clearly the legal principles in general keeping to the time allotted
- 1.9. Knowledge & use of legal sources, authorities & general principles of national law
- 1.10. Ingenuity (ability to argue by analogy from related aspects of the law)

#### 2. Written Submissions (Memorials)

- 2.1. The memorials shall be marked on a scale of 1-100 points each.
- 2.2. Any revisions, supplements, or additions to the memorials after submission shall attract severe penalties subject to the discretion of the National Administrator.
- 2.3. Award of the points shall be based on the following parameters:
  - 2.3.1. Neatness, legibility, typographical errors, or format errors
  - 2.3.2. The logical progression of ideas
  - 2.3.3. Effective use of headings to outline arguments.
  - 2.3.4. Understanding essential legal issues presented
  - 2.3.5. Focus on essential (not collateral) issues
  - 2.3.6. Clear, concise, and unambiguous writing style
  - 2.3.7. Forceful and persuasive presentation
  - 2.3.8. Integration of facts into a legal argument
  - 2.3.9. Understanding of strengths and weaknesses of the case
  - 2.3.10. Discussion of viable alternative arguments







- 2.3.11. Understanding and analysis of authority
- 2.3.12. Proper use of citations and citation form
- 2.3.13. Effective use of authority to support arguments
- 2.3.14. Ability to distinguish adverse cases

#### XV. ANONYMITY

- 1. Student counsel may introduce herself/ himself to the court through their Team Codes and side represented. However, the team's college/ institution affiliation may not be mentioned at any time before the awards ceremony.
- 2. Further, all team members, coaches, advisors, and observers shall refrain from identifying a team's school at any time and in any manner, including, but not limited to, wearing any identifying items, such as school clothing, ties, patches, or pins or carrying identifying material (such as a book with a college logo, or college seal).







#### XVI. POLICY FOR VIRTUAL ROUNDS

- 1. The Oral Rounds for the competition will take place virtually via the Google Meet platform
- 2. It would be the responsibility of every team to ensure a stable internet connection. The audio and video of every member of the team should be clear. Every team must ensure a proper background. The organizers will under no circumstances be obligated to provide the participants with any such facility.
- 3. All participants should mandatorily join with their laptops or desktops and other forms of devices are to be avoided.
- 4. The link for the room on the platform will be conveyed to the participating teams before the oral rounds.
- 5. Each team is required to join the room at least twenty minutes before the scheduled time of commencement of the oral rounds.
- 6. The participants' camera and microphone shall be firmly positioned throughout the oral rounds to show speakers and to ensure their voices are clearly audible.
- 7. All participants must keep their cameras on at all times during the rounds. The camera is to be switched off in case of technical glitches with the permission of the bench.
- 8. At the time when one participant is speaking, others are expected to keep their microphones on mute. In case a participant is found disturbing the other pleader anyway, he/she or the entire team to which such participant belongs may be disqualified upon the discretion of the bench.
- 9. Each participant is responsible for finding a suitable venue and background to participate. The venue must be a quiet location and one which has adequate and reliable internet connectivity and has a desk and chairs for the oralist. Locations in open spaces or hallways or cybercafes or similar areas are NOT permitted.
- 10. Participants are cautioned to ensure that all equipment has a power supply sufficient to last for at least two hours without interruption.
- 11. In case of a loss in internet connection, each team will be given a reasonable time to reconnect. If the problem persists the decision made by the organizers shall be final and binding.
- 12. If one or both of the speakers could not join due to connectivity issues, the team may be disqualified from the competition, and under no circumstances can another member of the team be allowed to switch roles.







- 13. Where a team does not appear within 10 minutes of the scheduled time for the round, the round shall proceed as ex-parte.
- 14. Any compiled Research Material (Compendium) or other supplementary documents may be, as per the discretion of the bench, presented by the team by using the "screen sharing" option given they have fulfilled to submit a soft copy along with the memorials, post the orientation on **18th August 2023**.
- 15. Participants will not be allowed to use the feature of personal chat on the platform in which the competition is hold to communicate with their team members or members of the opposing team.
- 16. Participants can only sip water on-screen during the competition. Consumption of other beverages or eatables is not permitted.
- 17. Participating speakers and researcher are permitted to join the Virtual Competition from the same premises/room. However, the screen space shall be independent, and the speakers, and researcher to represent before the bench through individual/separate devices.
- 18. Appropriate court room demeanour is to be maintained. This is mandatory.
- 19. Participants are expected to cooperate with the organizers and the judges, in case anyone faces any issue.
- 20. The organizers shall take the best available measures to resolve or mitigate any connectivity issues that may arise. However, in cases where that is not possible, the organizer cannot be held responsible for the unforeseen issues which include (but are not limited to) Software failure and connectivity issues.

#### XVII. FINALITY

- a. The decision of the judges shall be final and binding in regards to the oral rounds and memorial submissions.
- b. In the case of any conflict regarding the composition of the team, the decision of the National Administrator will be final.
- c. In the case of gross misdemeanor, the decision of the Organizers in consultation with the judges will be final.







- d. In the case of conflict regarding a situation outside the scope of the rules, the decision of the Organizers will be final.
- e. The Administrator retains the right to amend the rules of the competition at their discretion, with the concurrence of the National Administrator.

#### XVIII. RESEARCHER'S TEST

- 1. The Researcher's Test shall be conducted on August 18th, 2023 via online medium.
- 2. The Researcher's Test shall be in the format of both Multiple & Subjective questions with questions based on the applicable law, precedents, and facts pertaining to the Moot Proposition.
- 3. Participation in the Researcher's Test is mandatory for all the Teams and failure to participate may result in disqualification, subject to the discretion of the OC.
- 4. The duration of the Researcher's Test shall be informed 2 days before the dates of the competition and only the researcher, as designated by the teams in the registration form shall write the test.
- 5. The participant shall ensure complete integrity and shall not resort to unfair means while attempting the test. Any such attempt shall result in disqualification.

#### XIX. COPYRIGHT

- 1. The copyright over the memorials submitted for participation in the competition is assigned by participants and shall also vest completely and fully in, Surana & Surana International Attorneys, Chennai and UPES School of Law, Dehradun. The participants shall be responsible for any claim or dispute arising out of the further use and exhibition of these materials.
- 2. Further use and exhibition of these materials, electronically or otherwise, shall be the exclusive right of Surana & Surana International Attorneys, Chennai, and UPES School of Law, Dehradun, and they shall not be responsible for any liability to any person for any loss caused by errors or omissions in this collection of information, or for the accuracy, completeness, or adequacy of the information contained in these materials.
