#### TRIAL ADVOCACY - MOOT PROPOSITION

### **UNDISPUTED FACTS**

Ms. Juliet, an 18-year-old student in the First year of her undergraduate studies at Queen Margaret university, in Venice, a state in Democratic Republic of Indiana, commuted daily using a state-run public bus, Route 50-C. The conductor of this bus, Mr. Romeo, aged 50, was known for his friendly demeanor and frequent interaction with regular commuters, including Ms. Juliet.

According to the complaint filed by Ms. Juliet's mother, Mrs. Emily - a widow employed in housekeeping - an informal acquaintanceship between her daughter and Mr. Romeo allegedly began in July 2023, when Ms. Juliet was still a minor under the law of Indiana. Over time, this association reportedly developed into a close personal relationship. Mrs. Emily claimed to have observed inappropriate phone conversations, suspicious behavior, and was even informed by other commuters about the unusual proximity between her daughter and Mr. Romeo. Multiple warnings issued by the family were allegedly ignored by both parties.

The situation escalated when, on 29<sup>th</sup> September 2024, Mrs. Emily and other relatives discovered Ms. Juliet locked inside Mr. Romeo's private residence at Silver Grow Apartments. Upon being denied entry, Mrs. Emily and other relatives forcibly intervened and removed Ms. Juliet from the premises. A First Information Report (FIR) was promptly registered at the W-45 All Women Police Station, Anne Nagar, Venice, under Section 5(c) read with Section 6 of the Protection of Children from Sexual Offences (POCSO) Act, 2012.











The police arrested Mr. Romeo upon receiving a complaint. A confession was recorded, wherein the accused allegedly admitted to repeated sexual encounters with Ms. Juliet, some of which occurred when she was a minor. The statement also mentioned that physical relations continued even after she attained majority. Medical reports corroborated the occurrence of sexual activity but were inconclusive on whether force was used.

Ms. Juliet, in her statement recorded under Section 183 of the Criminal Procedure Code of Indiana (CPCI), admitted to having had sexual relations with Mr. Romeo but claimed she was madly in love with him. Now the case is posted for trial.

### A) Details of Parties

#### State:

Inspector of Police, W-45 All Women Police Station, Anne Nagar, Venice.

Romeo, Age 50, S/o. Montague, No: 20/25, Silver Grow Apartments, Fifth Floor, "VI" Block, 7th Main Road, Anne Nagar, Venice.

#### **B)** Nature of Information:

On 30-09-2024, at around 9.30 A.M, the complainant Mrs. Emily, W/A 42, W/o. Mr. Edward, appeared at the station and gave a complaint stating that her daughter Ms. Juliet, aged 18, studying, B.A. Economics at Queen Margaret university, has been traveling by bus route 50-C since she started college. The accused, who was the conductor of that bus and is identified in the margin, initially befriended her. From July 2023, he developed an inappropriate relationship with the victim minor and sexually harassed the minor multiple times. Despite being warned several times, he continued his relationship with her daughter. On 29-09-2024, at around 9.30 P.M, he took the victim minor on his bike to his house, and both were inside with the door locked. When asked to send the victim minor, he refused. So, with the help of her relatives, she rescued her daughter. Therefore, she requested action against the said Romeo, who is of her daughter's father's age, for having an inappropriate relationship with her daughter and subjecting her to sexual harassment multiple times. Based on this complaint, a case has been registered as cited under reference, and investigation is underway.

## D) If it appears that any offense has been committed in this case, by whom? How? When?

The incident in this case occurred within the jurisdiction of W-45 Anne Nagar All Women Police Station, at No: 20/25, Silver Grow Apartments, Fifth Floor, "VI" Block, 7th Main Road, Anne Nagar, Venice.

The victim minor in this case, Ms. Juliet, aged 18, used to travel to college by bus route 50-C. The accused, Romeo, W/A 50, who was working as a conductor on the same bus, with the intention of having an illicit relationship with the victim minor who was of his daughter's age, from July 2023, spoke lovingly to the minor, took her out, and took her to his residence at Silver Grow Apartments on more than one occasion and the act of the accused, who committed severe penetrative sexual assault, is an offense punishable under Sections 5(c) r/w 6 of the POCSO Act 2012.

This is the charge.

### E) Was the accused arrested? Or not?

Yes. The accused was arrested on 30-10-2024 and remanded to judicial custody.

### F) Was the accused released on bail?

Yes.

### G) Was he sent to judicial custody under Section 190 CPCI.? Or not?

Yes.

I humbly request that Hon'ble Madam take up this case for court trial and render due justice.

### Statement of Mrs. Emily under 180(3) CPCI

Statement of Mrs. Emily, W/A 42, W/o Mr. Edward, No. 23/10 Paladium Road, 10<sup>th</sup> Block, Anne Nagar, Venice under 180(3) CPCI.

Date: 30.09.2024

I reside at the above address. I work in Housekeeping. My husband is deceased. I have two daughters one is Ms. Juliet, aged 18, and another daughter named Ms. Emma, studying in class 12. My elder daughter is pursuing B.A. in Economics, at Queen Margaret University. She is in her first year of under graduation. My elder daughter travels to college by 50-C State-run public bus. Sometimes she goes from our house, and sometimes from my elder sister's house at No.5/1947 Roger Street, Palace Garden, 6<sup>th</sup> Block, Anne Nagar, Venice. She boards the bus daily at Anne Nagar bus stop. Mr. Romeo, the conductor of the 50-C bus she travels on daily, started talking to my daughter on the phone and befriended her from July 2023. When I learned that their acquaintance had turned into an inappropriate relationship, I warned my daughter and that conductor several times.

Meanwhile, the said Conductor Mr. Romeo, who is of my husband's age, used to call my daughter's phone all night and talk to her. When I reprimanded her, my daughter would deceive me by saying she had deleted the Conductor's number and was not talking to him. In this situation, on August 16, 2023, my maternal uncle Mr. Potter, who had come to my house, saw the bus conductor's photo on my daughter's phone. When he asked my daughter about it, she lied that it was her friend's father's photo. So, I had told him about my daughter's behavior and asked him to keep an eye on her. As he was monitoring, he saw my daughter and Mr. Romeo talking on the bus with his arm on her shoulder and also hugging her. Based on what he told me one day, both of us reprimanded my daughter and the bus conductor Mr. Romeo. At that time, he apologized to us. After that, one day my uncle called me and said that after college, Ms. Iuliet and that bus conductor Mr. Romeo had come to the beach and asked me to come to the beach as well. When I went there and saw my daughter with the bus conductor together at the beach, we reprimanded them both. At that time, he fell at my daughter's feet and my feet, apologized, and cried. Considering Ms. Juliet's future well-being, we forgave him then and did not file any complaint against him.

I asked my daughter when this relationship started and why she was doing this as he was of her father's age. She said that in July, she had unknowingly lost her phone which was in her handbag. To find it, she had given her mobile number to him and asked him

to give a missed call. Since then, he had been continuously talking to her and befriending her. He then told her various alluring words, saying she was beautiful, and in September 2023, he took her out and also took her to his residence in Anne Nagar and forced her into a physical relationship despite her refusing and trying to stop him. After that, citing the physical relationship, he took her to his house about 8 times and had physical relations with her. Lastly, even on 14.08.2024, he took her to No: 20/25, Silver Grow Apartments, Fifth Floor, "VI" Block, 7th Main Road, Anne Nagar, Venice, and had physical relations with her, she said. Considering my daughter's future wellbeing, I did not disclose this to anyone.

In this situation, today, 29-09-2024, at around 9.30 P.M as usual, I called to ask if my daughter had returned home, but she did not pick up the phone. So, when I told uncle, Mr. Potter, he went to the Anne Nagar bus stop where my daughter usually alights and saw the said conductor taking my daughter on his bike. I conveyed this information to my elder sister's daughter, Ms. Hermione, by phone and asked her also to come to the Silver Grow Apartments, Anne Nagar, where the conductor resides. When we went there, the conductor's house door was latched from the inside. We knocked on the door and asked conductor Mr. Romeo about my daughter. He was unwilling to send my daughter out with us and lied that my daughter was not with him. After that, we rescued my daughter from him.

Therefore, based on the complaint I gave requesting legal action against Mr. Romeo, who befriended my daughter, had a physical relationship with her, and ruined her life, a case was registered, and I have narrated the events for your investigation.

### Statement of Ms. Juliet under 180(3) CPCI

Statement of Ms. Juliet, W/A 18, D/o Mr. Edward, No. 23/10 Paladium Road, 10<sup>th</sup> Block, Anne Nagar, Venice under 180(3) CPCI.

I reside at the above said address. I am Juliet, aged 18 years, currently pursuing my B.A. in Economics at Queen Margaret University. I am in my first year of undergraduate studies. I usually travel to college by the 50-C State-run public bus. I sometimes travel from my home and sometimes from my maternal aunt's house located at No.5/1947, Roger Street, Palace Garden, 6th Block, Anne Nagar, Venice. I board the bus daily from Anne Nagar bus stop.

The conductor of this bus, Mr. Romeo, who is of my late father's age, began speaking to me and befriended me around July 2023. Initially, I had lost my phone which was in my handbag, and in the process of trying to retrieve it, I gave my mobile number to Mr. Romeo and asked him to give a missed call. After that, he started calling me frequently and speaking to me. He praised my appearance, flattered me with alluring words, and gained my trust.

In September 2023, he took me out and also took me to his house in Anne Nagar, where he forced me into a physical relationship despite my resistance and refusal. Thereafter, taking advantage of the situation, he repeatedly called me and compelled me to visit him. He took me to his house about 8 times and continued the physical relationship with me. She and my uncle, Mr. Potter, confronted Mr. Romeo on multiple occasions, including when they saw us together at the beach. At that time, he apologized and fell at our feet, and we forgave him, considering my future and to avoid any public embarrassment.

Despite these warnings, on 29-09-2024 at around 9.30 P.M, I did not respond to my mother's call as I was again with Mr. Romeo. My uncle, Mr. Potter, who had gone to the Anne Nagar bus stop, saw Mr. Romeo taking me on his bike. My cousin, Ms. Hermione, was informed, and we all went to Silver Grow Apartments. The house door was latched from the inside, and Mr. Romeo initially lied that I was not inside. Eventually, my











family members rescued me from his place.

I now fully realize the extent to which I was manipulated and taken advantage of by Mr. Romeo. I wish to give this statement in support of the complaint filed by my mother and to request appropriate legal action be taken against Mr. Romeo, who misused his position, induced me into an inappropriate and exploitative relationship, and thereby caused severe emotional and psychological harm to me.

This is my truthful statement given voluntarily

Statement of Ms. Hermione, W/A 29, D/o Mr. White, No.5/1947 Roger Street, Palace Garden, 6<sup>th</sup> Block, Anne Nagar, Venice, under 180(3) CPCI.

I reside at the above address. I have been working in the sales department at Tata Brand Cosmetic Shop in a store in Anne Nagar for the past 3 years. Ms. Juliet is my aunt's elder daughter. My aunt has been living with her daughters in Venice at No. 23/10 Paladium Road, 10<sup>th</sup> Block, Anne Nagar, Venice. Ms. Juliet alone has been going to college for the past 11 months, sometimes from our house and sometimes from my aunt's house. She boards the bus daily at Collector Bus Stand. Since she attends Evening College, she goes late. I also sometimes go to the shop late, and I would travel by the 50-C bus that Ms. Juliet usually takes. I have seen that bus conductor, Mr. Romeo, speaking to everyone with double-meaning words.

Similarly, last October 2023, one day Ms. Juliet boarded the 50-C bus at Anne Nagar Bus stop to go to college. He was on the phone with someone, telling them where the bus was. When I asked him who he was talking to, he said he was giving directions to his person. My younger sister boarded the bus at Anne Nagar bus stop. At that time, the way that bus conductor spoke to Ms. Juliet and behaved with her was not right. I immediately reprimanded them. I also told my aunt about it. She said she had also warned them several times and that the said conductor Mr. Romeo used to call Ms. Juliet at night and talk to her, and she did not listen even after being warned.

In this situation, today, 29-09-2024, around 9.45 PM, my aunt called us and said that Mr. Romeo was taking Ms. Juliet on his bike and asked us to go to No: 20/25, Silver Grow Apartments, Fifth Floor, "VI" Block, 7th Main Road, Anne Nagar, Venice, I went there. My aunt and uncle Mr. Potter were downstairs. When we went to Mr. Romeo's house, the door was latched from the inside. When my aunt knocked on the door and asked about Ms. Juliet, he was unwilling to send Ms. Juliet out with us and lied that she was not with him. After that, we rescued Ms. Juliet from him. When we asked Ms. Juliet, she said that she had been friendly with him since July 2023 and had gone out with him frequently. She also said that in September 2023, he took her to his house once, and despite her refusing and trying to stop him, he forcibly had physical relations with her. Similarly, she said he had physical relations with her about 8 times, and even on 14.08.2024, he took her and had physical relations with her. Therefore, regarding the complaint given by my aunt requesting action against the said conductor.

My mother-in-law Anne, aged 80, stays at home with me. I have seven siblings. A girl named Ms. Juliet used to travel frequently on 50-C bus. She is doing her B.A. in Economica at Queen Margaret university. That girl boards the bus at Anne Nagar bus stop and alights at Queen Margaret university. Last July 2023, Ms. Juliet said she had lost her mobile phone on the bus and asked for my number, so I gave it to her. I saved her number and called her the next day. From then on, we both started talking. Later, we both went to many places. I enticed her with sweet words and took her to my house and forcibly had physical relations with her. Like this, I had physical relations with her many times. When her family members came to know that we were both friendly, they warned us. Still, we both used to talk secretly and go out. On 14.08.2024, as it was her birthday, I invited her to my house, and there, I enticed her with sweet words and forcibly invited her for physical relations. When she refused to come, I again forcibly had physical relations with her. On 29.09.2024, in the evening around 09.30 P.M, I deceived Ms. Juliet with sweet words and took her to my house. Ms. Juliet's mother, wondering where she had gone, followed her and knocked on my door, asking if her daughter Juliet was in my house. I denied that she was there. After that, her mother called Juliet's maternal uncle. Then four people cornered me and beat me up. The next day Emily went and complained in the police station. The police investigated and











brought me to the Anne Nagar All Women Police Station. Based on the complaint given by Juliet's mother, you questioned me today, and I have stated what happened.

Sir.

On 30-09-2024, at around 9:30 A.M, the complainant, Mrs. Emily, W/A 42, W/o. Mr. Edward, appeared at the station and lodged a complaint stating that her daughter, Ms. Juliet, aged 18, a B.A. Economics student at Queen Margaret University, started taking the 50-C bus to college. The accused, who was the conductor of that bus and is mentioned in the margin, initially befriended her. From July 2023, he developed an inappropriate relationship with the affected minor, sexually abused her multiple times. Despite being warned several times, he continued his contact with her daughter. On 29-09-2024, in the evening, he took the affected minor on his bike to his house, locked the door, and they were inside. When asked to send the affected minor out, he refused. With the help of her relatives, she rescued her daughter. Therefore, she requested action to be taken against the accused, Romeo, who is of her daughter's father's age, for maintaining an inappropriate relationship with her daughter and sexually abusing her multiple times. Based on the complaint, a case was registered as per reference, and an investigation is being conducted.

From the above, it is evident that the accused mentioned in the margin, knowing that the affected minor was of his daughter's age and a minor, maintained an improper relationship with her and sexually abused her multiple times through intercourse.

It is necessary to subject the accused to judicial custody for the following reasons:

- If the accused is at large, he may threaten and tamper with the witnesses.
- The accused may abscond.
- The affected Victim may face further threats from the accused.
- For having sexually abused the minor girl, who is of his daughter's age and travelled in his bus, multiple times without regard for her being a minor.
- Because there is no safety for other minor girls travelling in the bus.
- To prevent such unfortunate incidents from happening to any other minor girl.

Therefore, it is humbly submitted that it is necessary to arrest the accused and subject him to judicial custody.

## Refer to the Guidelines and Protocols, Medico legal care for survivors/victims of sexual violence issued by the MoHFW, http://mohfw.nic.in/showfile.php?lid=2737

The examining doctor should carefully read the Guidelines for responding to survivors of sexual violence issued by the MoHFW, and should be well aware of the comprehensive care to be provided.

- 1. Informed consent: Doctors shall inform the person being examined about the nature and purpose of examination and in case of child to the child's parent/guardian/person in whom the child reposes trust. This information should include:
  - a. The medico-legal examination is to assist the investigation, arrest and prosecution of those who committed the sexual offence. This may involve an examination of the mouth, breasts, vagina, anus and rectum.
  - b. To assist investigation, forensic evidence may be collected with the consent of the survivor. This may include removing and isolating clothing, scalp hair, foreign substances from the body, saliva, pubic hair, samples taken from the vagina, anus, rectum, mouth and collecting a blood sample.
  - c. The survivor or in case of child, the parent/guardian/person in whom the child reposes trust, has the right to refuse either a medico-legal examination or collection of evidence or both, but that refusal will not be used to deny treatment to survivor after sexual violence.
  - d. As per the law, the hospital/ examining doctor is required to inform the police about the sexual offence. However, if the survivor does not wish to participate in the police investigation, it will not result in denial of treatment for sexual violence. Informed refusal will be documented in such cases.
- 2. Per vaginum examination, commonly referred to by lay persons as 'two-finger test', must not be conducted for establishing an incident of sexual violence and no comment on the size of vaginal introitus, elasticity of the vagina or hymen or about past sexual experience or habituation to sexual intercourse should be made as it has no bearing on a case of sexual violence. No comment on shape, size, and/or elasticity of the anal opening or about previous sexual experience or habituation to anal intercourse should be made.
- 3. Injury documentation: Examine the body parts for sexual violence related findings (such as injuries, bleeding, swelling, tenderness, discharge). This includes both micro mucosal injuries which may heal within short period to that of severe injuries which would take longer to heal. Please refer to section VI Point 17 of the Guidelines.
  - Injuries must be recorded with details size, site, shape, colour.
  - If a past history of sexual violence is reported, then record relevant findings. Sexual violence is largely perpetrated against females, but it can also be perpetrated against males, transgender and intersex persons.
- 4. The nature of forensic evidence collected will be determined by three main factors- nature of sexual violence, time lapsed between incident of sexual violence and examination and whether survivor has bathed or washed herself. Please refer to Section VI Point 21of Guidelines.
- 5. Opinion: The issue of whether an incident of rape/sexual assault occurred is a legal issue and not a medical diagnosis. Consequently, doctors should not, on the basis of the medical examination conclude whether rape/sexual assault had occurred or not. Only findings in relation to medical findings should be recorded in the medical report.
  - Drafting of provisional opinion should be done immediately after examination of the survivor on the basis of history and findings of detailed clinical examination of the survivor.
  - It should be always kept in mind that normal examination findings neither refute nor confirm sexual violence. Hence circumstantial/other evidence may please be taken into consideration.
  - Absence of injuries may be due to:
    - o Inability of survivor to offer resistance to the assailant because of intoxication or threats
    - Delay in reporting for examination





#### Accused:

Romeo, W/A 50, S/o. Montague, No: 20/25, Silver Grow Apartments, Fifth Floor, "VI" Block, 7th Main Road, Anne Nagar, Venice.

In the case seen in the file, it is understood that the accused seen in the margin, the conductor of the 50-C bus which the minor victim takes to college, Mr. Romeo, W/A 50, S/o. Montague, initially befriended the victim minor since July 2023, then had a relationship beyond their age difference with the victim minor, sexually assaulted her multiple times, and despite being warned multiple times, continued the relationship with her daughter. On 29-09-2024 evening around 9:30 PM, the victim minor was taken by the accused on his bike to his house, and they were inside after closing the door. When asked by the victim minor to send her, he refused. With the help of relatives, she rescued her daughter and brought her back. Therefore, she requested action against Mr. Romeo, who is the same age as her daughter's father, for having a relationship beyond











their age difference with her daughter and sexually assaulting her multiple times. Based on the complaint seen in the file, a case has been registered and investigation is being conducted. It is understood that the accused seen in the margin sexually assaulted the victim minor multiple times by entering forcefully, despite knowing she was a minor. Therefore, I request that the accused be subjected to a medical examination for potency at Anne Medical College Hospital PC - 52359, Mr. Albertina, PC 55928, Mr. Robertina are being assigned official duty and sent to produce him. I humbly request that a medical examination be conducted on the accused seen in the margin at Anne Medical College Hospital and a medical report be provided.

- 1. Is the accused potent?
- 2. Is the accused capable of sexual intercourse?

His secondary sexual characters, penis, scrotum and testis normally developed.

The skin over the penis, scrotum, and inner aspect of thighs were normal.

There is no injury, scar or ulcer over the genitalia, inner aspect of thighs and pubic area. There is no enlarged or tender regional lymph nodes in the pubic and inguinal region, there is no discharge from the urethra.

There is no external evidence of Sexually Transmitted Diseases.

The skin over the penis is not circumcised, smegma absent, pubic hair not matted.

Reflexes are normal. Nervous system is normal.

On Per Rectal Examination Prostate normal. He is able to erect his penis.

Ms. Juliet is physically 18 years old. The psychological assessment was carried out as part of the ongoing legal proceedings, and the findings are intended to assist the court in understanding the victim's mental and intellectual capacities.

#### **III. Evaluation Procedures**

The following tools and methods were used during the assessment:

- Clinical Interview
- Behavioral Observation
- Standardized Intelligence Testing (Name of test, e.g., Wechsler Intelligence Scale or equivalent)
- Mental Status Examination











#### IV. Observations

During the assessment, Ms. Juliet presented as cooperative and responsive. However, her cognitive processing speed, comprehension level, and problem-solving abilities were observed to be below expected levels for her actual age.

#### V. Test Results and Interpretation

Mental Age: Approximately 16 years

IQ Score: 85

Classification: Below Average Intellectual Functioning

The results indicate that Ms. Juliet functions at a cognitive level approximately two years behind her chronological age. The IQ score of 85 places her intellectual functioning in the "below average" range according to standard classifications.

#### VI. Conclusion and Opinion

Based on clinical observations and standardized testing, it is my professional opinion that although Ms. Juliet is 18 years old physically, she possesses a mental age of approximately 16 years with an IQ of 85. These findings are indicative of mild cognitive delay but do not fall within the range of intellectual disability. Her ability to comprehend complex situations and make mature decisions may be limited.
