RULES OF THE COMPETITION

I AIM AND PURPOSE

The Surana & Surana and UPES School of Law's Insolvency Law Moot Court Competition aims to facilitate understanding of evolving jurisprudence in Insolvency Law emerging trends. It also focuses on enhancing research, writing, and advocacy skills. By participating in this competition, individuals have the opportunity to enhance their legal acumen and contribute to the growth of this specialized field.

II **DEFINITIONS**

- 1. Advanced Rounds: It shall refer to the Quarter Finals, Semi Finals, and a Final Round of The Competition.
- 2. Competition: It shall refer to the VIIIth edition of the Surana & Surana and UPES School of Law, Insolvency Law Moot Court Competition, 2025.
- 3. **Disqualification**: It shall render a team invalid to continue participating in the Competition.
- 4. **Judge**: It shall refer to any person appointed to evaluate a Participant's Memorial or Oral Pleading.
- 5. **Memorial**: It shall refer to the written arguments submitted by each team, on behalf of both the Parties, according to the official competition rules.
- 6. Chief Administrator: It shall refer to the Dean, School of Law, UPES (Chairman, Moot Court Committee, UPES).
- 7. **Oral Rounds**: It shall refer to a team's pleadings, composed of both speakers, submitted orally in front of the judges, on behalf of one of the parties, against another team representing the opposing party.
- 8. **Parties**: It shall refer to the parties to the dispute as identified by the case record as Informant/ Appellant and Opposite Party/Respondent.
- 9. **Penalties**: It shall refer to points deducted for violation of any Rules mentioned hereunder.











NOTE: The organizing committee reserves the authority to disqualify any team if there is any grave violation of these Rules.

- 10. **Preliminary Rounds:** It shall refer to the Oral Rounds which will take place prior to the Advanced Rounds of the Competition for the purpose of determining the teams which will proceed to the Advanced Rounds.
- 11. **Rules**: It shall refer to these official Competition Rules and such other applicable supplements to these Rules published by the Organizing Committee.
- 12. Organizing Committee: Shall mean and include members mentioned in brochure.
- 13. **Scouting**: It shall refer to the act of attending a round in which the members of the team or any person related to the team are not competing.
- 14. **Team Code**: It shall refer to the unique number allotted to each participating team for the purpose of this Competition. This would primarily be used for all submissions of memorials.
- 15. **Competition Code**: For the oral rounds, based on the fixtures, competition codes will be allotted through a draw of lots as part of the orientation.

III VENUE AND DATE

Surana & Surana and UPES School of Law, Insolvency Law Moot Court Competition shall be held on campus / offline Mode. The offline rounds will take place on 14th - 16th November 2025 in the Kandoli Campus of UPES.

IV **LANGUAGE**

The competition shall be conducted in the English language.


V **ELIGIBILITY**

The competition is open for students who are pursuing LLB (three-year / five-year) courses during the current academic year.











VI TEAM COMPOSITION

1. The maximum number of participants per team shall be restricted to 3 wherein only 2 shall be speakers and 1 shall be the designated researcher. The researcher shall be allowed to argue with the prior permission of the court and Chief Administrator in case of illness of the designated speakers.

Note: Only the designated speaker in the Preliminary Rounds shall be eligible for the Best Student Advocate award.

- 2. No Team Coach, mentors, observer or any other person shall be accompanying registered participating team members.
- 3. Teams should not disclose the identity of their institution; such disclosure shall invite penalties including disqualification. The decision for the same shall be at the discretion of the Chief Administrator.

VII **REGISTRATION**

• Provisional Registration

- 1. Provisional Registration commences from 5th August 2025.
- 2. The Provisional Registration shall be done by **16th September 2025**. It is mandatory for every university to register provisionally via its moot court's ID at LINK.
- 3. Teams will receive confirmation mail of the successful provisional registration from the Host University.

• Final Registration

- 1. Final Registration for teams commences from 5th August 2025.
- 2. The teams must register online by 30th September 2025. Teams will have to register online at www.moot.in
- 3. After registering online, the teams must complete the Registration Process as stated below by sending a copy of the documents for authentication, at mootcourt@ddn.upes.ac.in
- 4. Participants will receive approval as acceptance of their request for participation within 2 days from the last date of registration.











• Registration Process

The following documents are required by the teams at the time of Final Registration:

- (i) An external participation form / approval letter (with seal and signature) as provided in the rules (refer to page no. 25) duly filled from the participant's institution / moot society.
- (ii) Scanned copy of the receipt of online payment.

Note: Signatories on the registration form should be any of the following: Faculty- in charge of MCA / MCS / MCC, Registrar, Dean, Principal, Director, Vice-Chancellor. *Submission of the registration form in the prescribed format is mandatory without any exception.

· Registration Fee

The following documents are required by the teams at the time of Final Registration:

A registration fee of **Rs. 5000** /- (**Rupees Five Thousand Only**) is to be paid online by the team through Net Banking.

An additional amount of **Rs. 1000/-** (**Rupees One Thousand Only**) per day per participant is to be paid online to cover their accommodation and food.

VIII CLARIFICATION

- 1. Teams may seek clarification latest by 13th October 2025. (11:59 PM IST) through the link shared by the committee by email to mootcourt@ddn.upes.ac.in & ai@lawindia.com LINK
- 2. All the clarifications shall be posted on www.moot.in and emailed to all the participants on their respective email-ids provided in the registration form by 14th October 2025.

IX WRITTEN SUBMISSION

- 1. Each Team is required to prepare Written Submissions for both sides, i.e., the Applicant(s)/Claimant(s)/Petitioner(s) and the Respondent(s) of the case. A Written Submission shall be identified solely by the Team Code assigned to the Team under the Rules of the Competition. The Written Submissions shall not, in any way, disclose any fact about the Identity of the Team, its members, or the Institution/College/University represented by the Team.
- 2. The cover page of the memorial should be Blue for the Applicant(s)/Claimant(s)/Petitioner(s) and Red for the Respondent(s), respectively.
- 3. The soft copy of the Memorials for the Applicant(s)/Claimant(s)/Petitioner(s) and the Respondent should be submitted in a zip folder on <u>LINK</u> and also email to <u>mootcourt@ddn.upes.ac.in</u> and <u>ai@lawindia.com</u> on or before **18**th **October 2025** (11:59PM IST). Late submissions will be penalized by one point each per memorial for every hour of delay.
- 4. The memorials shall be submitted in Word format as well as PDF Format.

 The file shall be named as "Team Code- Appellant" and "Team Code- Respondent" respectively. Once the soft copy of the memorials has been submitted, no revisions, supplements, or additions will be allowed.
- 5. The submissions shall be the original work of the team. The similarity (Plagiarism) for a Memorial should not be more than 15%.
- 6. The teams are requested to submit 8 hard copies of memorials of both sides (each Appellant & Respondent) on **14th November 2025** on the registration desk.











- 7. A Written Submission shall consist of the following mandatory heads:
 - A. Cover Page
 - B. Table of Contents
 - C. List of Abbreviations
 - D. Index of Authorities
 - E. Statement of Jurisdiction
 - F. Statement of Facts (not exceeding 2 pages)
 - G. Issues Raised
 - H. Summary of Arguments (not exceeding 2 pages)
 - I. Arguments Advanced (not exceeding 30 pages)
 - J. Prayer (not exceeding 1 page)
- 8. The Cover Page of a Written Submission must contain the following information:
 - A. The Team Code in the upper right-hand corner in accordance with the Rules of the Competition.
 - B. The name and year of the Competition
 - C. The name of the case
 - D. The side for which the Written Submission has been prepared
 - E. Name of the forum resolving the dispute.
- 9. Teams shall cite all authorities in the Written Submission using footnotes as per Bluebook (21st Edition).
- 10. The Written Submission shall not contain any annexures, photographs or any other representation of nature.
- 11. The Written Submission (including the preliminary pages and excluding the cover page) shall adhere to the following mandatory specifications:
 - A. Paper size: A4
 - B. Font type: Times New Roman
 - C. Font size: 12
 - D. Line spacing: 1.5
 - E. Body of text: Justified
 - F. Margin: 1 inch on all sides
 - G. Page Numbering: Top right side of each page

For footnotes, the formatting specifications are:

- A. Font type: Times New Roman
- B. Font size: 10
- C. Line spacing: 1
- D. Paragraph spacing: 0
- E. No additional space between 2 footnotes
- F. Body of text: Justified











The identity of the institution shall not be revealed anywhere in the memorial. Violation of this provision shall result in penalties including disqualification. The Organizing Committee's decision shall be final.

X <u>COMPENDIUM</u>

- 1. Teams are required to submit their compendium at the mootcourt@ddn.upes.ac.in via email to Moot Court Committee. Only then will they be allowed to present it during the rounds. Teams can present their compendium via screen-sharing during the virtual rounds and physically during the offline rounds.
- 2. In case of failure of a team to submit a compendium to the organizing committee, the team shall not be allowed to share the compendium with the bench.
- 3. Any identifying marks/seal of the college shall attract severe penalties including disqualification. There will not be any passing of notes to the judges. The compendium will have to take care of this requirement. The teams can take them back after the respective rounds.
- 4. It is not mandatory for the teams. However, if a team is making one then they are required to submit it via e- mail by 18th October 2025 (11:59 PM).

XI RESEARCHER'S TEST

- 1. The Researcher's Test shall be conducted on 13th October 2025 via the Online medium.
- 2. The participant shall ensure complete integrity and shall not resort to unfair means while attempting the test. Any such attempt shall result in disqualification.
- 3. Necessary Details will be mailed to the respective team members after their Soft Copy Submission.
- 4. The top **16 Teams** will qualify for the on campus/offline rounds to be held from 14-16th November, 2025.


XII ROUNDS

- 1. There will be two Preliminary Rounds, Quarter-final, a Semi-Final, and a Final Round which will be conducted Offline at the campus of UPES Dehradun. Octa-Final rounds would be conducted only at the discretion of the organizing committee depending on the number of teams.
- 2. Octa Final Rounds will be conducted if the Registration exceeds 24 Teams.
- 3. Oral Rounds











1. Preliminary Round

- 1.1. There will be two preliminary rounds of arguments per team, once on behalf of the Appellent and another on behalf of the Respondent on 15th November 2025.
- 1.2. No team shall appear before each other more than once in the Preliminary Rounds.
- 1.3. Each team will face a different bench of judges in their second round of arguments.
- 1.4. Each team will get a total of **30 minutes** to present their case. This includes time for rebuttals.
- 1.5. The division of time is at the discretion of the team members, subject to a minimum of **10 minutes** and a maximum of **15 minutes** per speaker. Division of time shall be informed to the court officer/moderator before arguments begin.
- 1.6 The researcher shall sit with the speakers at the time of the Oral Rounds.
- 1.7 Extension of time will be allowed only at the judges' discretion.

2. Quarter Final

- 2.1. Quarter Final will be held on 15th November 2025
- 2.2. These will be a knockout round.
- 2.3. Each team will get a total of **30 minutes** to present their case. This includes time for rebuttals.
- 2.4. The division of time is at the discretion of the team members, subject to a minimum of 10 minutes and a maximum of 15 minutes per speaker. Division of time shall be informed to the court officer/moderator before arguments begin.
- 2.5. The researcher shall sit with the speakers at the time of the Oral Rounds.
- 2.6. Extension of time will be allowed only at the judges' discretion.

3. Semi-Final Rounds

- 3.1. The Semi-Final Rounds will be held on 16th November 2025. The pairing of Teams for the Semi-Final Rounds shall be done by a draw of lots/power matchups.
- 3.2. Each team will get a total of **45 minutes** to present their case. This includes time for rebuttals.
- 3.3. The division of time is at the discretion of the team members, subject to a minimum of **20 minutes** and a maximum of **25 minutes** per speaker. Division of time shall be informed to the court officer/moderator before arguments begin.
- 3.4. The researcher shall sit with the speakers at the time of the Oral Rounds
- 3.5. Extension of time will be allowed only at the judges' discretion.

4. Final Round

4.1. The Final Rounds will be held on 16th November 2025. The sides for the final rounds will be determined by a draw of slots.











- 4.2. Each team will get a total of **45 minutes** to present their case. Further **5 minutes** for rebuttal and sur-rebuttal. (Total time for each team = 45 + 5).
- 4.3. The division of time is at the discretion of the team members, subject to a minimum of **20 minutes** and a maximum of **25 minutes** per speaker. Division of time shall be informed to the court officer/ moderator before arguments begin.

5. Results

5.1 The Final result and the winners of the various categories will be announced only during the valedictory ceremony on **16th November 2025.**

XIII DRESS CODE

The dress code for the competition shall be as per the Bar Council of India Rules for Advocates.

XIV SCOUTING

- a. Teams will not be allowed to observe the oral rounds of any other teams. Scouting is strictly prohibited. Scouting by any of the team members shall result in disqualification.
- b. In the virtual format, the presence of any team member in the virtual courtroom of any other team except their own will qualify as Scouting.


XV ANONYMITY

Student counsel may introduce herself/ himself to the court through their Competition Codes and sides represented. However, the team's college/ institution affiliation may not be mentioned at any time before the Valedictory Ceremony. Further, all team members, coaches, advisors, and observers shall refrain from identifying a team's school at any time and in any manner, including, but not limited to, wearing any identifying items, such as school clothing, ties, patches, or pins or carrying identifying material (such as a book with a college logo, or college).











XVI. EVALUATION CRITERIA

XVII FINALITY

- 1. The decision of the judges shall be final and binding regarding the oral rounds and memorial submissions.
- 2. In the case of any conflict regarding the composition of the team, the decision of the chief Administrator will be final.
- 3. In the case of a gross misdemeanor, the decision of the Organizers in consultation with the judges will be final.
- 4. In the case of conflict regarding a situation outside the scope of the rules, the decision of the Organizers will be final.
- 5. The Administrator retains the right to amend the rules of the competition at their discretion, with the concurrence of the Chief Administrator.

XVIII COPYRIGHT

- 1. The copyright over the memorials submitted for participation in the competition is assigned by participants and shall also vest completely and fully in, Surana & Surana and UPES School of Law, Dehradun. The participants shall be responsible for any claim or dispute arising out of the further use and exhibition of these materials.
- 2. Further use and exhibition of these materials, electronically or otherwise, shall be the exclusive right of Surana & Surana and UPES School of Law, Dehradun, and they shall not be responsible for any liability to any person for any loss caused by errors or omissions in this collection of information, or for the accuracy, completeness, or adequacy of the information contained in these materials.

XIX ACCOMODATION & TRANSPORTATION
